Putting your affairs in order – checklist

- Make a will
- Prepare other instructions: e.g. funeral preferences, advance directives, mandate for future protection
- Designate one or more trusted persons to represent you when you are no longer able to manage your interests
- List all bank accounts, pensions, and other investments
- Collect personal certificates such as birth, marriage, divorce, etc.

[www.service-public.fr](http://www.service-public.fr) , the official website of the French administration, contains pragmatic information on many useful topics. The details provided will help you with end-of-life planning and information gathering for a file giving instructions in the event of your death – or after an accident or serious illness when you may be unable to express yourself.

### Making a will

A will can be made alone, without a notary; this is known as a holographic will, which can even be in a foreign language. Your will can also be entrusted to a notary and centralized in the FCDDV (fichier central des dispositions de dernières volontés). More rarely, you can create a mystic will in a sealed envelope which does not reveal the contents.

Drawing up a mandate for future protection (mandat de protection future) allows any person of legal age (called the mandator) to designate in advance one or more persons (called the mandatary) to represent him/her on the day when he/she is no longer able to manage his/her interests.

If someone has died, this page sets out the steps you need to take to organize the funeral and inform various organizations:

- Register the death (in France or abroad)
- Notify next of kin
- Declare the death at the town hall (mairie)
- Notify the employer
- Request leave of absence from your employer
- Check the deceased's last wishes
- Organize the funeral

- Notify the deceased's bank
  - Notify any employees of the deceased and take care of the contract
  - Pay for the funeral
  - Contact social organizations.

#### Managing the deceased's papers and personal data

- Determine what needs to be done about taxes
- Manage the deceased's principal residence and real estate assets
- Manage the deceased's vehicles
- Gather the necessary documents and information making up the deceased's estate.

#### Documents to report as you put your affairs in order

- Last wishes, including a will and choice of funeral, potential donation of the body to science, and organ removal
- Advance directives (the recommendation is that they can be deposited with your GP, 'mon espace santé', or a relative – also ADMD, see 'Useful Websites', below)
- Papers, passwords, and other key information can be considered taking into account document retention time.

In the absence of a national file set up by the public authorities, advance directives can be filed with ADMD. ADMD already holds the advance directives of almost 50,000 members.
